- Fee will be collected after adjustment of dues of each cadet. Above mentioned fee is as per authorization.
- ii) School Fees will be increased by 10% every year as per the standing directives of Board of Governors, Sainik Schools Society, Ministry of Defence.
- iii) If the Scholarship holders fail to submit income documents on the due dates i.e., on or before 09 JULY 2021, they will be treated as Full Fee Payee and less fee will not be accepted from them.
- iv) Late payment charges will be imposed on late payment of half yearly fee/dues by due date @ Rs.20/per day from the last date given.
- v) Scholarship holders desirous to withdraw will have to refund the total scholarship enjoyed by the student during his stay in the School.
- vi) If a child is withdrawn by the parent voluntarily at any time during the term, the fee will be charged up to the end of that Academic Session.
- vii) In case the parent wants to withdraw his son on any account he must give a notice of withdrawal in writing to the Principal, at least two months before the commencement of the next term i.e., on or before 31 Jan of the same year. Failure to give this notice will entail forfeiture of caution money. Once opted for withdrawal no permission will be granted for rejoining.
- viii) <u>Diet Charge will be recovered from the Cadets as per actual expenditure as and when cadets join the school.</u>
